Dearest Neffers.

This is a letter of comment on The National Fantasy Fan Vol. 79 #2 (February 2020). In early June, George sent me a brief email saying, "I hope that you and yours are well and safe. I haven't heard from you in a bit, and hope that at some point you will be sending the N3F more of your fine letters and reviews." It is true—after a flurry of renewed activity earlier this year, I slowed down some, and truth be told, the plague knocked the winds out of my sails a little. Oh, I'm still reading and watching and thinking, but for some reason, I wasn't fanning. My family is as happy and healthy as we can be during these times of plague and quarantine, and things have reached a point where even if normalcy can't be sought (now is not the time to venture forth or relax our vigilance), some semblance of normal activity needs to return. And so it does.

Every Tuesday night, a friend and I watch the same movie, either streaming somewhere or on DVD if we both own the DVD. We used to get together for actual screenings at my home every other week, but we've increased the frequency needing contact outside the home. We watch the same movie, texting each other throughout. Recent screenings have included Forbidden World (1982), Cotton Candy (1978), The Vast of Night (2019), Puppet Master (1989), Alligator (1980), and Phantasm (1979). And tonight: War of the Colossal Beast (1958).

On RPOL online, I recently started running a D20 Conan game using the Mongoose materials. It's a scenario pulled from an issue of Signs & Portents, and we're just getting started. I've never played or run this particular game before but wanted to swim in some Conan RPG seas. Embarrassingly, I couldn't find my copy of the more recent Modiphius 2D20 book, so opted for the older edition. Such is the fate of a clutter bug and pack rat. If you can't find what you're looking for, you make do with what you do find.

And I finally collapsed and applied to join the Los Angeles Science Fantasy Society, which I've orbited since moving here in 2009, but never actually joined as a member. Here's the email I sent the secretary and treasurer with my application:

"Attached is my application to join the LASFS. I'm not sure what the application protocol is during times of plague, but I know it's high time I apply, and I need to stop waiting to do so. I hope that Marty [Cantor] and others remember me, but you might not. I moved to LA in 2009 and hung out rarely in the old

Prince Valiant and Harold R. Foster by Jon D. Swartz, Ph.D. N3F Historian

Prince Valiant in the Days of King Arthur, or simply Prince Valiant, is a long-running newspaper comic strip created by Canadian-born cartoonist Harold R. (Hal) Foster in 1937. It is an epic adventure that has told a continuous story during its entire history, and the full stretch of that story now totals nearly 4,000 Sunday strips. Currently, the strip appears weekly in more than 300 newspapers in the United States, according to its distributor, King Features Syndicate.

Generally regarded by comics historians as one of the most impressive visual creations ever syndicated, the strip is noted for its realistically rendered panoramas and the intelligent, sometimes humorous, narrative. The format does not employ word balloons. Instead, the story is narrated in captions positioned at the bottom or sides of panels. Events depicted have been taken from various time periods, from the late Roman Empire to the Middle Ages, with even a few scenes from modern times.

When the strip started in 1937, Prince Val was five years old. The first episodes followed the youth through the wild Fens district of Britain with his father, the deposed King Aguar of Thule. When Val encountered the witch Horrit, she predicted he would have a life of adventure, but also said that he would soon experience grief. Arriving home, Val discovered that his mother had died. Not long after that came his encounters with Sir Gawain, his fights with various gigantic creatures, and his discovery of the glory of Camelot.

Newspaper Strip

Prince Valiant began in full-color tabloid sections on Saturday, February 13, 1937. The first full page was strip #16, which appeared in the Sunday New Orleans Times Picayune. The internal dating changed from Saturday to Sunday with strip #66 (May 15, 1938). The full-page strip continued until 1971, when strip #1788 was not offered in full-page format. It was the last strip Foster drew. The strip continues today by Mark Schultz and Thomas Yeates, in a half-page, or smaller, format.

Comic Books

Prince Valiant has appeared in comic books since the 1930s, when reprints of his strips were published in *Ace Comics*. In 1941 his stories were reprinted in *Feature Books Number 26* – an issue that now sells for hundreds of dollars. Later he appeared in the Dell 4-Color series in all-new stories illustrated by comic book artist Bob Fuji (Robert Fujitani). More recently

"Let me know if applying like this is outre, gauche, and such—and if it's fine, let me know how the vote goes. I'd like to pay dues monthly for the rest of 2020 and annually otherwise, because I want to belong to the LASFS even if I can't be in the same room with you. "I've waited too long!"

It's really true. I have. All Neffers should support their local sf club, if there is one. Do you belong to one? What's it like? What do you do? What's going on now that we're all homebound?

I am so excited about voting for the Neffies this year. I've added the anime to my queues streaming, found where I can watch a couple episodes of the nominated TV shows, and gotten ebooks of all the short and long fiction under consideration. I've read almost all of the short stories and novellas—and there's some fine stuff in there. I am so excited about voting for the Neffies this year that I'm already planning ahead for the nominating period next year. I totally missed the nomination window this year, and even if I'd been on the ball, I wasn't ready to nominate the best of 2019. But next year, I will be. As I read the little magazines this year, I'll shortlist stories to nominate. And so on. You should do the same! The deadline for voting this year is July 15. Don't miss it!

Seeing the April-June convention calendar made me sad about these plague times. When we're able to again, please support your local sf club and con—I know I'll miss Loscon this year, despite not always being able to participate. (In fact, that's another reason I want to join the LASFS. We need to support things like this to keep them going even when we can't make meetings, go to cons, and so on.)

Jon, I enjoyed "My First Comic Book." Thank you for sharing your stories—and your memories of Ron Goulart!

I got the new issues of Analog and Asimov's in the mail recently but haven't read anything inside yet. What have you been reading, watching, and doing?

his exploits have been reprinted in a series of comic books that began the 1980s.

Big Little Books

While it came as something of a shock to me that there were no *Prince Valiant* Big Little Books by United States publishers, I was pleased to learn that there had been at least one Prince Valiant BLB published – in Argentina in the 1940s: *El Principi Valiente*. Of course, this BLB is written in Spanish.

Other Books

Fantagraphics has been publishing reprints of *Prince Valiant* in book form for years. In addition to these, and other, reprint volumes of the newspaper strips, there have been other *Prince Valiant* books – including Golden Books and coloring books for children.

Prince Valiant Movie

Robert Wagner, Janet Leigh, James Mason, Sterling Hayden, Brian Aherne, and Debra Paget starred in a Technicolor *Prince Valiant* movie from 20th-Century Fox in 1954. The movie was shot in Cinemascope, and a very young Wagner played Prince Valiant.

Television

"The Legend of Prince Valiant" aired during the 1991-1994 TV seasons, with Robbie Benson as Prince Valiant, Efrem Zimbalist Jr. as King Arthur, Alan Oppenheimer as Merlin, and Samantha Eggar as Queen Guinevere.

Postage Stamp

There was a United States 32-cent Prince Valiant postage stamp issued in 1995 to commemorate the strip.

Merchandise

There have been many Prince Valiant toys over the years, including several toy swords and scabbards. Other merchandise has included shields, sets of trading cards, board games, a role-playing game, a mechanical dime bank, calendars, a lunch box, posters, play sets, mugs, Easter egg transfers, wax candles, a Prince Valiant syroco figure (plus other figures from the strip), a Dark Horse Prince Valiant figure, a Reelart statue of Prince Valiant on his horse, spinning tops, puzzles, a castle fort, a crossbow pistol game, Christmas cards, and ashtrays.

Harold R. (Hal) Foster

While drawing the *Tarzan* comic strip, Foster (1892 - 1982) wanted to do his own original newspaper feature, and he began

work on a strip he called *Derek, Son of Thane*, later changing the title to *Prince Arn*. King Features manager Joseph Connelly eventually renamed it *Prince Valiant*. In 1936, after extensive research, Foster pitched his concept to publisher William Randolph Hearst, who had long wanted to distribute a strip by Foster. Hearst was so impressed that he gave Foster ownership of the strip.

Papers of Foster, including correspondence, original artwork, and color proofs for *Prince Valiant*, scrapbooks and photographs, printed material, as well as material related to Foster's appearance on the television show, "This is Your Life," are all housed in the Special Collections Research Library at Syracuse University.

Some Conclusions

Prince Valiant set a standard that few other comic strips have attained. As summarized by comics historian and critic Coulton Waugh, writing in 1947: "It is much more than a comic strip – or perhaps more truthfully, we should say that the comic medium has been stretched by "Prince Valiant" to include almost the ultimate in absorbing and realistic illustration. It would be of high quality among the high-priced children's illustrated books, and here it is, all yours for a dime."

Bureau Reports

Writer's Exchange

Judy Carroll writes: I think it would be fun, exciting, and informative if our writers would actively participate in the monthly Writers Exchange article. We could get to know one another and help with writing questions and problems.

In May, Jefferson Swycaffer, a long time member of the N3F contributed, and in June, Angela Parsons Myers, a new N3F

member, contributed. I want to thank them for bringing some excitement to this monthly article.

I would like to see a lot of our writers frequently contributing. Since I don't give up easily, when it's something I really care about, I am going to continue requesting input from our N3F writers. I know there are a lot of you out there.

The question for this month is - Do you find it easy to come up with a title for your work, be it an article, short story, novel, screenplay, or whatever?

My answer to this question is, "No." I have always had trouble coming up with a title.

As a child I came up with names for my dolls and plush animals at a much faster rate than I ever have for a short story or an article. I never named a brown bear Brownie or a doll by the name the manufacturer called her. I would stare at the new member of my family while names ran through my head. When I found one I thought might be acceptable I would say it out loud while still staring at the doll or plush animal. If I didn't get an "aww, that's it feeling" I continued until my heart and my mind were in agreement. Sometimes I would actively introduce them to the rest of my "family."

As I grew older I began to tell my little sister stories - all original Judy stories. The naming of the stories didn't come in the same manner as naming the dolls and plush animals. Sometimes I would have a title pop into my head and I had to build a story around it. I have found this method to be much easier than finding a title for an article or story I have already written.

I don't remember what my titles were like in junior high and high school English classes. In my senior year of high school I was on the school paper during the first semester. My titles tried to be informative and interesting. In my second semester I transferred to the creative writing class, which had just been resurrected from the dead. My poems and short stories had short titles - many times only one word.

Then in college English the "crazies" hit. I couldn't come up with a title that said what I wanted nor that made any sense. I remember only part of a title to one of my stories. It had something about a knight and charging forth. When I think of this, which is not very often, my mind sees a knight in full armour, visor down, riding a white horse with his lance held in front of him, charging a white box of detergent (?). When the teacher was returning our graded assignments, I do remember I could tell when she came to mine. Her face looked puzzled as if she were trying to figure out where she was. A few assignments later she only had to look at the title to know who's paper she was holding.

I have told you about my problems with picking a title. Now, I would like to hear how some of our writers choose a title.

The Constitution of the National Fantasy Fan Federation

Preamble:

The activity that centers around science fiction and fantasy has grown to require organization in order that desirable objectives, beyond the achievement of single individuals, may be attained through united effort. Under this Constitution, the National Fantasy Fan Federation (N3F) is established as an association of persons interested in promoting the progress of science fiction and fantasy, and in furthering its enjoyment by themselves and others.

Article 1 – Membership:

1. Membership, including any benefits created by the organization, and all rights such as voting, is gained be paying dues as set forth in the Bylaws. Dues changes may not go into effect until two(2) months after publication in the Official Organ and shall be further delayed until the completion of voting if the Official Organ receives a petition for submission as set forth in Article V, Section 1 for reversal, unless the change is the result of a vote on petition.

- 2. An organization may become a member of the N3F upon payment of dues as defined in Section 1 and is entitled to all rights and benefits of membership as outlined in this Constitution except that said organization may not vote or hold elective office.
- 3. Joint memberships are available to two persons residing in the same household. A joint membership will include The National Fantasy Fan Federation (TNFF) and all rights such as voting and club activities. The dues shall be more than a single membership but less than a double, to be set by the Directorate.

Article II - Officers

- 1. A President conducts the affairs of the organization. His/her appointments, suspensions, and removals from office, whether the office concerned is elective or appointive, are subject to the review and approval of the Directorate, as are also his/her methods of procedure.
- 2. If, for any reason, the office of President becomes vacant, the Directorate appoints a President to complete the unexpired term. Any interim administrative duties are performed by the Chairman of the Directorate, during which time he/she may not vote in his/her capacity as Director except on motions of appointment.
- 3. A Directorate, composed of five members, regulates the affairs and controls the finances of the organization, and may define the duties of any office or official of the association.
- 4. Decisions of the Directorate are by majority of its five members except in the following instances: by unanimous vote the Directorate may refuse membership to any person; expel any member by refunding the balance of his dues; and may remove the President from office.
- 5. Vacancies in the Directorate, whatever the cause, are filled by majority vote of the remaining Directors. If fewer than three Directors remain, the President shall appoint one or more up to the minimum of three.
- 6. Any person designated as Treasurer or otherwise empowered to keep or convey the funds of the organization must be over twenty-one years of age.
- 7. The Treasurer shall also have free dues as long as he or she holds office.

Article III - Elections

- 1. The President and five members of the Directorate are decided by the membership in an annual election of those officers. Ballots for the election are to be distributed before October 10th and the elected candidates take office on the following January 1st. Any member may seek office by complying with the official requirements which are to be published in the Official Organ at least two months previous to the filing deadline.
- 2. No person may hold two elective offices at the same time.
- 3. Each member may cast one vote for each of the five candidates of his/her choice in the election of the Directorate. The five candidates receiving the largest number of votes is elected. Ties are resolved by majority agreement of those elected candidates not included in the tie.
- 4. Of the candidates for President, the one receiving the largest number of votes is elected. In case of a tie, the elected Directorate chooses a President from the tied candidates.

Article IV - Official Organ

1. The association issues a publication of at least quarterly schedule which carries in addition to other material, a quarterly statement of the financial status of the organization, together with a listing of new members and their addresses.

Article V – Petitions & Amendments

- 1. Petitions of whatever purpose, endorsed by five per cent of the members or twenty-five members, whichever is less, must, within sixty days after the Directorate receives them, be submitted to the membership for decision unless the Directorate has already taken the indicated action. Petitions looking towards the revision, reversion, or setting aside of any action of the President or the Directorate must be submitted within two calendar years following such action, or such petition is invalid and without force.
- 2. Any motion by the Directorate approved for presentation to the membership to alter or amend the Constitution must be printed in the next TNFF, and in no event, not less than two months prior to the actual voting date, if not the result of action under Section I of this article.
- 3. Amendments to the Constitution shall require two thirds (2/3) of the votes cast to be approved. All other decisions by the membership shall be by a majority of the votes cast.
- 4. Any alteration or amendment of the Constitution will be presented to the membership for vote exactly as it is to be entered, or the alteration or amendment is invalid and without force.
- 5. The power to alter or amend the Constitution is vested solely in the membership.

The Bylaws of the National Fantasy Fan Federation

I. Authority

Under the authority implied in Article II, Section 3 of the Constitution of the National Fantasy Fan Federation, the Directorate shall establish certain Bylaws to regulate the affairs of the organization, such Bylaws to be effective when approved by a majority vote of the Directorate as set forth in Article II, Section 4, of the Constitution.

II. The Directorate

- 1. The Chair of the Directorate shall report to the membership all measures passed by the Directorate. The Chair of the Directorate shall maintain updated copies of the Bylaws, distribute them to the Directorate, President, Treasurer, and Official Editor of The National Fantasy Fan (TNFF), at the beginning of the year and whenever changed, and direct that current copies of the Bylaws and Constitution are maintained on the club website.
- 2. Copies of all official Directorate correspondence shall be sent to the President and Treasurer.
- 3. Each Directorate shall adopt standing rules of procedure, which shall remain in force for the Directorate of the follow

ing year, until such time as the new Directorate shall vote to accept them or adopt new rules.

4. A Director who has not voted or participated in Directorate discussion or correspondence in any period of three consecutive months may be declared inactive by the Directorate, and may be removed by the President for this cause only, without prejudice.

III. The Treasury

- 1. The President or designated person may bill the Treasury, as needed, for expenses incurred in the discharge of the office, including the purchase of supplies for new members, the sum not to exceed \$100 per year.
- 2. The Treasurer will assist the President in maintaining a current online membership roster by reporting new membership payments, renewals, and changes of address to the President and such other officers as the President may direct, not less often than once a month.
- 3. The Treasurer will prepare a yearly report of all income to the N3F Treasury and an itemized list of expenditures. Also included in this report will be a listing of items which will require additional outlays, in the forthcoming year from the Treasury, and have been approved by the Directorate, but have not yet been paid. This report will be prepared for the first issue of TNFF to appear in the year following the year which the report covers.
- 4. The President shall not hold the office of Treasurer, except on a temporary basis not to exceed 4 weeks due to vacancy or emergency. If the president fails to appoint a replacement within three weeks of an office vacancy or either the Treasurer, the Directorate shall move on its own to appoint a replacement for the vacant office.

IV. Elections

- 1. All candidates must, by the filing deadline of August 15 of each year, have paid their dues for the year in which they will hold office if elected, and agree to serve if appointed under Article II, Section 5 of the Constitution.
- 2. In addition to the regular candidates listed on the ballot, members may write in the name of any member in good standing as a candidate for any elective office. Any candidate so elected must submit a written statement of his willingness to serve plus the dues for the year in which he will serve within 14 days of his notification of election. In the event of noncompliance with the foregoing, the election will be voided and the candidate receiving the next highest number of votes for that office will be declared the winner.
- 3. Annual election platforms are to be printed in the September issue of TNFF. The election ballot will either be printed in the September issue of The Fan or mailed to members separately. Members may submit either a photocopy of the election ballot or vote from an email account previously registered with the secretary rather than the ballot itself. Each paper ballot shall include space for the N3F member to write their name in print, provide their signature and also the date the ballot was completed. Ballots for Constitutional amendments and other membership referendums may also be sent out with TNFF.

V. Publications

The intent of this club is to distribute at least one publication each month to members in good standing in the form of either the Official Organ or other publication as follows:

- 1. Regular publications of the N3F: The N3F has two regular publications: The National Fantasy Fan (TNFF), the Official Organ, and Tightbeam (TB), a member-created fanzine.
- 2. Special Publications may be issued upon approval of the President.
- 3. Publication Officers: The Official Editor and Publisher are appointed by the President. Editors of special publications are appointed by the Official Editor with the President's approval.
- 4. Printing: The Publisher shall print enough copies to send to every regular member of the N3F as of the date of publication, plus any other extra copies that the President may direct the Publisher to print.
- 5. The National Fantasy Fan shall be published at least quarterly with no more than four months between issues.
- 6. In the event a Regular Publication does not appear as scheduled, the President shall appoint a Stand-by Editor. This Editor shall be reimbursed as if he were the regular Editor if the magazine is mailed within two months after the appointment by the President.
- 7. Required Notices: TNFF shall contain a list of new members and renewals in each issue; the Constitution and Bylaws of the N3F in the Summer quarter; and the roster of the membership in the Spring and Autumn quarters.
- 8. Submission Deadlines: Deadlines for material submitted shall be the 15th of the month preceding the month of publication. Any deviation from this date must be announced in the previous issue.
- 9. Reimbursement. The treasury shall reimburse expenses for printing and mailing regular publications. Total annual reimbursement per voting member household from the Treasury for printing and postage shall not exceed \$14 for 12 issues. No single issue of a regular publication may exceed a printing cost of 50 cents per issue, without Directorate approval. The Publisher shall notify the Chairman of the Directorate of receipt of any issue not conforming to this limitation, before printing. All other publication reimbursements require Directorate approval.
- 10. Advertisements in N3F publication are free, restricted to N3F members, and are subject to space limitations in the judgment of the editor.
- 11. The N3F Roster, while available for membership use, is not for sale as a mailing list to anyone.
- 12. Others. Publications issued by subordinate Bureaus of the N3F and not sent to the entire membership shall be sent to the President or other designated person for information and record. In the case of N'APA that shall be construed to mean the Alliance Amateur or other official business publication and not the entire bundle. The cost will be borne by the Treasury of the N3F upon presentation of an itemized bill to the Treasurer.
- 13. Neffer Amateur Press Alliance. All N'APA members must be members in good standing of the N3F.
- 14. Exchange Agreements. The President can authorize ex-

change agreements with other publishers who will receive all N3F publications, and the President or other designated person will receive all their publications.

15. Standing Rule. Fandom rests on honest recognition of the creative works of others. If in an N3F-sponsored activity there are reasons to believe that nominally creative works claimed to be by a person appear to be copied from creative works of others, the person suspected of having copied without appropriate attribution will be presented by the President or Chair with the evidence and invited to explain the similarities. The President or Chair will report the person's response to the Directorate, which will choose an appropriate action, up to and including finding the person exonerated or returning dues and severing all connection between the N3F and the person.

VI. Rescissions

Directorate motions in the nature of Bylaws passed prior to the original compilation and publication of these Bylaws and not included among them, are rescinded.

VII. Amendments

Amendments to these Bylaws may be made with approval of a majority of the Directorate.

VIII. Dues

- 1. Membership dues are payable annually as follows:
- A. Regular Member: Individual memberships are \$18 per year, and include receiving one print copy of all club publications.
- B. Joint/Household Member: Dues are \$4 per year per person residing at the same household address at the same household address as a Regular, Life, or Electronic Member. This membership does not include print copies of club publications.
- C. Life Member: Dues are \$0 per year. Any Founding Member, as listed in the June 1942 membership list of the official organ, shall be granted life membership.
- D. Electronic Member: Dues are \$6 per year. This membership does not include print copies of club publications.
- 2. The number of Life or Honorary members, other than Founding Members, created by Directorate vote may not exceed 5 memberships or 1 percent of the total membership of the N3F, whichever number is greater. This rule shall not operate to reduce the number of existing Life memberships at any time.

IX. Member Benefits

- 1. The following membership benefits are reserved solely to dues-paying members ("paid members"): holding, running for, or being appointed to any elected office; holding the office of Treasurer, Publisher or Official Editor; voting for elected office; receiving printed copies of club publications paid for by the treasury; and representing the organization in any official capacity.
- 2. Life Members appointed by the Directorate are granted the same membership benefits as Paid Members, regardless of whether they pay dues or not.
- 3. Members of the general public may fully participate in all N3F activities except for those reserved solely to paid members.

2021 N3F Amateur Short Story Contest Story Contest Rules and Entry Blank

Now and then, it has been suggested to open the N3F Amateur Short Story Contest to professional writers, writers who have had one or two sales. I've never favored this. It is my opinion that we want new blood. We want to reward the new kids on the block. To be blunt, we want writing that is not that good. We want stories from people who don't know their object from their subject, who don't know where commas go, and who use apostrophes to denote plurals -- but who have a story to tell. I want stories from guys nobody's ever heard of...but in the years ahead, we will. Those who are already successful don't need the encouragement of our little contest. If they were to enter the contest, the danger is that they'd win, every time, and crowd out the promising newcomer.

- 1. This contest is open to all amateur writers in the field, regardless of whether they're members of the National Fantasy Fan Federation. For the purposes of this contest, we define an amateur as someone who has sold no more than two (2) stories to professional science fiction or fantasy publications.
- 2. Stories entered in the contest must be original, unpublished, not longer than 8,500 words in length—and must be related to the science fiction, fantasy, or similar genres in the opinion of the judge.
- 3. Email attachments of Word documents are acceptable for submission. Manuscripts on paper should be typed, single sided on 8 1/2"-by- 11" white paper, double spaced, with pages numbered. The name of the author should not appear anywhere on the manuscript to ensure impartial judging. Photocopies are acceptable, if they are of good quality. Computer printouts must be legible.
- 4. Contestants can enter up to three stories. Enclose a self-addressed, stamped envelope (SASE) if you would like your story returned at the end of the contest. Stories will not be returned without an SASE. Do not send your only copy in case of accidental loss. We are not responsible for lost manuscripts.
- 5. Email entries will be accepted. Send to Jefferson P. Swycaffer at abontides@gmail.com. No guarantee can be made of email receipt. Privacy and property rights will be absolutely respected. No one other than the Short Story Judge will ever see the submission.
- 6. There are no entry fees.
- 7. Cash prizes totaling \$100 will be awarded as follows: First prize is \$50, second \$30, and third \$20. Honorable mentions and semi-finalists will receive a certificate of award.
- 8. Send all manuscripts to the contest manager: Jefferson Swycaffer, P. O. Box 15373, San Diego, CA 92175-5373; abontides@gmail.com. Emails with the story attached in word format are preferred. Paper manuscripts are acceptable. All entries must be received or postmarked no later than Dec. 31, 2020.
- 9. The Short Story Judge is a published science fiction professional, and also a loving fan of the sf and fantasy genres. All comments and critiques are solely the Short Story Judge's opinion, but he promises to be constructive and polite.
- 10. Stories will also be reviewed by the Editor of the N3F Fiction zine Eldritch Science; authors of suitable tales will be invited to submit their tales for publication in our zine. This review and invitation will only occur after contest winners have been announced, so it can have no effect on the contest outcome.
- 101 The NSF may want to publish an electronic book including top entries from one or more years of publication. You will not be contacted about this until after the contest is over and prizes have been awarded. If we want to publish your story, you will have to sign over to us first world serial rights. Your willingness to sign over rights cannot affect whether or not you win the contest. Winners will be notified as soon as the judging is completed. Announcements and notifications of winning entries will be made by March 2021. Please take your time and submit your best work. You can resubmit stories previously entered if they did not win previously. All entries will be kept confidential and will be judged fairly and anonymously. The deadline for all entries is Dec. 31, 2021. Good luck!
